FUND MANAGER'S COMMENTS

For the month, the fund rose +0.93% in MYR terms, underperforming the benchmark by 133bps. The underperformance of the month was driven by Industrials, Information Technology and Real Estate.

KLCI gained 2.6% in April with the index settling at a two-year high. Local investors remain upbeat despite bets on rate cuts by the Fed pushed back given the persistent strong economic data out of the US and sticky inflation. The run-up was relatively broad-based. Malaysia's manufacturing sector improved in April with the PMI reading at 49.0pts vs 48.4pts in March. S&P Global saw evidence of demand conditions moving on an upward trajectory given the softer moderations in production, new business and purchasing, coupled with renewed expansion in new export sales to the strongest level in 3 years.

We took the opportunity to lock in more gains as the market continued to trend higher. We continue to deploy the cash into quality names that have lagged. We are still positive on the market and our key bets remain positioned in domestic driven sectors that stand to gain from the NETR, including Utilities, Construction, and Property. We are still positive on selective O&G names as we see value and we believe the sector will be supported by strong Petronas activities in the coming years. Key risks are the derailment of Malaysia's macro-economic recovery and corporate earnings growth due to the larger-than-expected impact of rising inflation, slower global economic growth, and heightened geopolitical risk.

The MSCI AC Asia Pacific ex Japan Index was almost flat in April, rising by only 0.33% in USD terms. The best performing markets were China, Hong Kong SAR while Indonesia and Korea lagged. In China, we continue to see green shoots emerging, with second consecutive month of PMI above 50 and 1Q24 GDP growth surprised on the upside, at 5.3%YoY. The market was buoyed by expectations of potential intervention in the housing market and Beijing and Tianjin announced to ease property purchase restrictions. We retain our view that China growth outlook hinges critically on government policies and be selective in our investments.

We have a positive view on Asian equities given attractive investment themes and corporates have the potential to post better earnings growth than developed markets in 2024. We will continue to diversify the portfolio and position the portfolio in areas where they are likely to print strong earnings growth such as the semiconductor industry, beneficiaries of AI spend, or rising capex as well as India. We will also be selective in our investments in China, especially for those companies who have shown signs of turnaround.

Stock specific risk

We aim to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.

Interest rate risk

Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments.

Country risk

Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall.

Currency risk
