FUND MANAGER'S COMMENTS

- The Fed left interest rates unchanged at 0-0.25% in January, stating that the pace of the recovery has moderated in recent months. The Fed will not consider tapering until it believes the economy is reaching towards maximum employment. On inflation, they expect an uptick in inflation in coming quarters due to the low base effect from 2020.
- The 10-year U.S. Treasury yields rose above 1% for the first time since March, reflecting increased bets on additional fiscal stimulus after Democrats won control over the Senate election. Similarly, DXY has been hovering around the 90 level in January from 89.93 at end-December.
- Primary issuances in Asia continue to see strong demand. A majority of these saw strong oversubscription. A synchronised recovery in the region as well as accommodative central banks, could lead to credit spreads tightening further.
- Asian credits continue to see healthy buying interest as credit spreads for both Asian IG and HY tightening. This was driven by improved market sentiments following the inauguration of Joe Biden as the new US President, and on expectations of a broad market recovery.
- Indonesia's central bank left its key interest rate unchanged at a record low at 3.75%, projecting optimism that the economy is recovering and inflation will remain tame even with new restrictions in place to fight a surge in Covid-19 infections.

STRATEGY: Rates are likely to remain low given concerns on low growth and lack of inflationary pressures. Focus will be on credit selection with government bonds to provide liquidity and trading opportunities.

- The Chinese property sector continues to be the main contributor for yield. We also added positions in Chinese govt bonds due to the attractive yield, strong reserves, and the economic recovery from the pandemic.
- We continue to favor quality names with a slight tilt towards the IG segment. Invested level is at ~93% and we intend to keep invested level at 90-95% for better opportunities.
- Duration remained at around 5.5 years while open FX positions were further reduced.

Structured products risk

This in turn may cause the NAV of the target fund or prices of units to fall.

Regulatory risk

These regulatory changes pose a risk to the target fund as it may materially impact the investments of the target fund. In an effort to manage and mitigate such risk, the fund manager seeks to continuously keep abreast of regulatory developments (for example, by closely monitoring announcements on regulators' website and mainstream media) in that country. The fund manager may dispose its investments in that particular country should the regulatory changes adversely impact the investors' interest or diminish returns to the target fund.
