FUND MANAGER'S COMMENTS

The Fund was down 3.77% in MYR terms in April, outperforming the benchmark by 4bps. YTD, the Fund is down 9.99%, underperforming the benchmark by 177bps. Developed markets continued to correct with a hawkish Fed. S&P 500, MSCI Europe and MSCI Japan declined by 5.4%, 1.8% and 2.7% respectively MTD in local currency terms. The US Dollar continued to strengthen by 4.7% MTD. Euro and Japanese Yen depreciated by 4.7% and 6.6% against the Dollar, respectively. US 10-year bond yield increased to 3.13% at the time of writing. The Fed delivered 20bps interest rate hike as expected and signaled another 50bps hike in upcoming meetings. In addition, the Fed has released details of its balance sheet reduction plan, starting in June.

US manufacturing output continues to expand strongly driven by strong demand. On the other hand, Japan's manufacturing sector may be pressured as external demand may be dampened by the lockdown restrictions in China. Europe's PMI eased as geopolitical tensions weighed on demand. Labor market is tight in US with a record high number of job vacancies that continue to push up wage pressure. Forward 12m corporate earnings were revised down for Europe. US and Japan still see positive earnings revision. US P/B-ROE valuation is slightly higher than historical mean. Japan and Europe valuations are cheap.

As geopolitical tensions and supply disruptions may continue to put upward pressure on commodity prices, inflation may continue to be a concern. We have added commodity and energy exposure to hedge inflation risk, which contributed to the Slight Overweight position in US. We maintain neutral allocations to other markets as we expect the issues of when inflation would moderate, the pace of its moderation, the Fed's tightening path and geopolitical tensions to weigh on markets in the short-term.
