FUND MANAGER'S COMMENTS

In September, the Fund fell 0.27% outperforming the benchmark by 2.61ppt as the Islamic index fell during the month led by China, Korea and Taiwan. Most countries posted negative returns except for India and Indonesia. YTD, the fund outperformed the benchmark by 4.53ppt.

As communicated by the US Federal Reserve, monetary policy normalization starting with bond tapering should begin towards year end. We expect tapering to wind down in mid 2022 with a lift-off in interest rates thereafter depending on the growth trajectory and labour market developments. The separation of bond tapering and interest rate lift-off in a gradual manner should provide leeway for Asian economies to reopen their economies and return their economies to normalcy before having their Central Banks follow the Fed in monetary policy.

As the energy shortage in China is likely to persist until 4Q, economic growth is likely to be weaker than expected in the coming months. Coupled with a slowdown in property market on the back of the government's implied stance on Evergrande, we are cautiously navigating China and mainly focusing in selected areas that do not have the potential to be socialized such as high-tech manufacturing and renewables.

We continue to diversify our holdings across countries and businesses to improve our portfolio's resilience. During the month, we top-sliced selected stocks that had performed well and trimmed cyclical names in materials and industrials exposed to China. We had deployed the proceeds to new names across telecommunications and renewable ideas such as solar and electric vehicle. Off-benchmark stocks contribute ~50% to our holdings.

If this occurs, Principal will take the necessary steps to dispose of such securities. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event that the Shariah non-compliant securities are disposed of at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund or price of units to fall.		
Risk associated with investing in Islamic CIS	Since the target fund will invest entirely into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.		
Country risk	The target fund may invest into Islamic CIS which can be domiciled in various countries. Therefore, the target fund will be subjected to risks specific to the countries in which the Islamic CIS are domiciled. Such risks include adverse changes in economic fundamentals, social and political stability, laws and regulations and foreign investments policies. These factors may have an adverse impact on the price of the Islamic CIS, which will depress the Islamic CIS's NAV growth, and consequently depress the target fund's NAV growth.
