FUND MANAGER'S COMMENTS

In December, the Fund rose +7.39% in MYR terms, outperforming the Benchmark by 270 basis points (bps) led by China. In 2021, the Fund rose +30.06%, outperforming the Benchmark by 8.74 percentage points.

With economic normalization, mass rollout of Covid vaccines in 2021 and abundant liquidity in capital markets, we expect Asian equities to perform well. While the complete rollout of vaccines will be a multi-year process that spans beyond 2021, the overall situation should be relatively more controlled with better awareness and measures to contain the spread of the virus. Under President Joe Biden, we expect the relationship between US and China to be no worse off than under President Trump and hence less negative shocks to the economic repair in China and in Asia. While there are reasons to be positive on equities, the risks are a) The pace and degree of recovery in earnings and economic activities as the equities has priced in some of these b) Further room for fiscal or monetary policy response either towards a strengthening or weakening of the economy since a lot of the heavy-lifting in terms of easing has been done in 2020.

We are fully invested and favour growth-oriented stocks. While we think the rally will broaden out, we are selective in picking companies that have long runway in terms of growth and are not overvalued. Recently, we have added positions in Chinese industrial automation and cement, tourism in Thailand and healthcare in India.

Stock specific risk

This in turn may cause the NAV of the target fund or prices of units to fall.

Currency risk

As the investments of the target fund may be denominated in currencies other than the base currency of the target fund, any fluctuation in the exchange rate between the base currency of the target fund and the currencies in which the investments are denominated may have an impact on the value of these investments. You should be aware that if the currencies in which the investments are denominated depreciate against the base currency of the target fund, this will have an adverse effect on the NAV of the target fund in the base currency of the target fund and vice versa. You should note that any gains or losses arising from the fluctuation in the exchange rate may further increase or decrease the returns of the investment.

Risks associated with investment in warrants and/or options

There are inherent risks associated with investment in warrants and/or options. The value of warrants and/or options are influenced by the current market price of the underlying security, the exercise price of the contract, the time to expiration of the contract and the estimate of the future volatility of the underlying security's price over the life of the contact. Generally, the erosion in value of Shariah-compliant warrants accelerates as it approaches its expiry date. Like securities, Principal will undertake fundamental research and analysis on these instruments with an aim to mitigate its risks.

Credit and default risk

The target fund will be exposed to a certain degree of credit and default risk of issuers or counterparties when the target fund invests in Sukuk and/or place Islamic deposits. Credit risk relates to the creditworthiness of the securities issuers or counterparties and their expected ability to make timely payment of profit and/or principal. Any adverse situations faced by the issuers or counterparties may impact the value as well as liquidity of the investments. In the case of rated Sukuk, this may lead to a credit downgrade. Default risk relates to the risk that a securities issuer or counterparty either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investments. This could adversely affect the value of the target fund. Principal aims to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.

RISKS (CONTINUED)

Interest rate risk

Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and Islamic money market instruments. When interest rates rise, Sukuk and Islamic money market instruments prices generally decline and this may lower the market value of the target fund's investment in Sukuk and Islamic money market instruments. In managing the Sukuk, Principal takes into account the coupon rate and time to maturity of the Sukuk with an aim to mitigate the interest rate risk. As for Islamic money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike Sukuk, any change to interest rate will only have a minor impact to the prices of these instruments.

Risk associated with investing in CIS

Since the target fund may invest into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.
