PERFORMANCE RECORD

This fund feeds into Principal Islamic Deposit Fund ("target fund") with the objective to provide investors with liquidity and regular income, while maintaining capital stability by investing primarily in Islamic deposit placements with licensed Islamic financial institutions that comply with Shariah principles.

FUND MANAGER'S COMMENTS

The Fund delivered 0.14% in the month of April, the benchmark is in line, and delivered 1.63% in the 12-months period ending April 2022, underperforming the benchmark by 10bps.

Malaysia's Industrial Production Index eased for the third consecutive month to +3.9% YoY in February (Jan-22: +4.3%) amid moderation in the manufacturing and electricity components, while mining remained stagnant. Meanwhile the manufacturing PMI showed a contraction in March as it declined to 49.6 (Feb-22: 50.9) as the prolonged Russian-Ukraine war and supply chain disruptions from China cities lockdown dampened sentiment but increased to 51.6 in April which was led by a sharp recovery in new order volumes.

Headline CPI remained unchanged at +2.2% YoY in March (Feb-22: +2.2%) despite higher food and non-alcoholic beverage prices (Mar-22: +4.0%; Feb-22: +3.7%) as diminishing base effects from transportation (Mar-22: +2.6%; Feb-22: +3.9%) amid continued fuel price subsidies helped to keep inflation levels stable. Meanwhile, core CPI edged higher in March to +2.0% YoY (Feb-22: +1.8%) amid pent-up discretionary spending and services demand effect of the economic reopening.

In March, exports grew by +25.4% YoY (Feb-22: +16.8%) on the back of firmer growth in manufacturing (i.e. E&E & petroleum products), agriculture and mining exports (i.e. palm oil, LNG and crude oil); while imports grew by +29.9% YoY (Feb-22: +18.3%) driven by imports of intermediate, consumption and capital goods. Trade surplus widened to RM26.7 billion during the month (Feb-22: RM19.8 billion).

We limit our investment exposure to short-term deposit placements due to the very low risk nature of the Fund.
