## FUND MANAGER'S COMMENTS

For the month, the fund rose +2.80% in MYR terms, outperforming the benchmark by +14bps. The outperformance of the month was driven by Communication Services, Materials and Consumer Discretionary.

The FBMKLCI fell 0.7%. Globally, growth stocks outperformed, with technology stocks leading the pack as US inflation cooled further as well as optimism from China's reopening. Gaming (+8%), Tech (+7%) and REITs (+6%) were among the biggest winners for the month, while Gloves (-7%), Plantations (-5%) and Healthcare (-4%) languished. During the latest MPC meeting, Bank Negara held its OPR at 2.75%, which was a surprise as consensus was expecting a 25bps hike. This marks the first pause after four consecutive rate hikes that began in May 2022. In a statement, BNM noted that this will enable them to assess the impact of the past OPR adjustments, which tends to have a lagging effect on the economy. Given the continued positive market momentum and the prospect of valuation upside, we remain cautiously positive on Malaysia market. On a balanced approach, we continue to focus on companies with firm fundamentals and strong cash flows generation. On top of that, we see opportunity in select Technology for structural growth.

On China's reopening theme, we prefer on tourism related stocks as well as select commodities in view of improved industrial demands. China's Covid, economic and regulatory policies are coordinated in favour of growth for the first time in 3 years. Caixin China PMI rebounded to above 50 as recovery in services led the improvement. We expect a more enhanced execution on economic growth, following its Two Session Meeting in March 2023 by the Chinese government. Hence, we favour beneficiaries of policy tailwinds and economic reopening. MSCI AC Asia Pacific ex Japan Index surged 8.6% in USD terms in January 2022. Taiwan, Korea and China were the best performing markets on the back of China's pivot to growth, while India and Indonesia were among the worst performers. The US 10-year bond yield retreated by 37bps to 3.5% as inflation continued to slow. Copper jumped more than 10% on the back of improving China economic outlook.

We have a positive view on Asian equities, as China economy recovers, and earnings growth in Asia is expected to be stronger than developed markets. We will continue to focus on quality companies which have good earnings visibility, robust balance sheet, long term winners, market share gainers and those with pricing power to overcome cost pressures.

We aim to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.
<b>Interest rate risk</b>	Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments.
<b>Country risk</b>	Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall.

### Currency risk

As the investments of the target fund may be denominated in currencies other than the base currency of the target fund, any fluctuation in the exchange rate between the base currency of the target fund and the currencies in which the investments are denominated may have an impact on the value of these investments. ### Risk of investing in emerging markets

We attempt to mitigate these risks through active asset allocation management and diversification across different countries and sectors, in addition to our continuous bottom-up and top-down research and analysis.

The value of warrants is influenced by the current market price of the underlying security, the exercise price of the contract, the time to expiration of the contract and the estimate of the future volatility of the underlying security's price over the life of the contract. Like securities, we will undertake fundamental research and analysis on these instruments with an aim to mitigate its risks.
