FUND MANAGER'S COMMENTS

- KLCI benchmark slipped by 0.90% w-o-w, mirroring movements in regional indices as investors remained cautious, awaiting direction from the US presidential election outcome. Sector-wise, the primary detractors were property, construction, and technology, while the plantation sector emerged as the market's bright spot, supported by a surge in crude palm oil (CPO) prices, which approached RM5,000 per tonne.
- Foreign investors continued their net selling streak in end October, extending the trend that began in late September. However, on a year-to-date basis, foreign inflows remain positive, with net purchases totalling RM2.6 billion. We also saw profit-taking activities among domestic institutional investors looking to boost ROI. However, we expect this selling trend to reverse as government-linked investment companies (GLICs) start positioning portfolios for the upcoming year.
- In local developments, U Mobile Sdn Bhd was selected to implement Malaysia's second 5G network. The company has highlighted Celcom-Digi and Telekom Malaysia (TM) as potential partners for delivering advanced 5G services, though other telecom players remain in the mix as negotiations continue. This announcement could help remove a major overhang for the sector in terms of additional capex.

STRATEGY:

- Cash deployed & reduced to 3.7% from 6.5%, highly invested at the moment.
- We made some strategic purchases into we increased exposure to plantation, and airline stocks, specifically Capital A Bhd.
- We also nibble on selected tech names, as valuations appear to be bottoming-out as the sector heads for a recovery next year.
- Added some position in Press Metal Aluminium Hldg Bhd and Gamuda Bhd, other names were rebalanced.
- Positioning remains focused in growth and cyclicals to capitalise on the improved market sentiment. About 30% of the fund are in defensives / yield to anchor against volatility.

Failure to achieve these would result in declining investment value which in turn affects the performance of the target fund. This can be mitigated by diversifying the target fund's portfolios.

RISKS (CONTINUED)

This risk refers to the risk that the currently held Shariah-compliant securities by the target fund may be reclassified to be Shariah non-compliant in the periodic review of the equities by the Shariah Advisory Council of the Securities Commission Malaysia (SACSC), the Shariah Adviser for the target fund or the Shariah boards of the relevant Islamic indices.

Reclassification of Shariah status risk

If this occurs, AHAM Asset Management Berhad will take the necessary steps to dispose of such equities. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess capital gains derived from the disposal of the Shariah noncompliant equities. AHAM Asset Management Berhad will be required to dispose of these equities immediately if the prices are above the purchase price. Should the prices be below the purchase price, AHAM Asset Management Berhad may choose to hold on to these holdings until the prices meet the purchase price. Nevertheless, should AHAM Asset Management Berhad decide to dispose of these equities below the purchase price, the target fund will be faced with the risk of realising its losses, thus negatively impacting the NAV of the target fund.

Shariah-compliant warrants investment The value of the Shariah-compliant warrants ("warrants") will depend on the pricing of the underlying security whereby the growth and performance prospect of the underlying security would consequentially affect the value of the warrants.
