FUND MANAGER'S COMMENTS

Sector allocation was broadly neutral as the continued drag from being underweight the soaring Energy sector was offset by the underweight to Consumer Discretionary and overweight Utilities. Stock selection was negative coming primarily from Communication Services.

Impact Focus: The Target Fund Manager has initiated positions in Tesla and Adobe over the month. The Target Fund Manager has long admired both companies for different reasons but felt them to be priced far too richly, however after both suffering extremely sharp sell offs year to date, the Target Fund Manager saw enough margin of safety to initiate small positions. The Target Fund Manager's impact thesis for Tesla is that as the world leader in Electric Vehicles ("EV"), it is having a hugely positive impact both directly as a result of the emissions avoided through its products and indirectly as a result of the huge pressure its innovation within the EV space has put on all automakers to accelerate the transition to EVs. For Adobe, although not core to its operations document reader PDFs attached to emails have vastly lowered the amount of physical mailings of documents, and Adobe Acrobat Sign has driven a very large reduction in the need for physical documents reducing deforestation and helping carbon capture.

Top contributors were Umicore (+15%) and NextEra Energy (+7%). NextEra has benefitted from improving sentiment around the prospect of tariffs and the impact on its solar pipeline whilst Umicore has benefitted from speculation that it could be a target for an Asian peer that has been open about its intentions to acquire within Europe. Safaricom (-24%) and Johnson Controls (-9%) were the greatest detractors. Investors were understandably disappointed by the update on the trajectory of Safaricom's Ethiopia operations and predicted investment levels, however the selloff in the stock has been magnified by very low liquidity and the Target Fund Manager believe the core Kenyan business to be significantly undervalued at current levels.
