PERFORMANCE RECORD

This fund feeds into Principal Islamic Deposit Fund - Class AI ("target fund") with the objective to provide investors with liquidity and regular income, while maintaining capital stability by investing primarily in Islamic deposit placements with licensed Islamic financial institutions that comply with Shariah principles.

FUND MANAGER'S COMMENTS

The Fund delivered 0.28% in December 2023, which was outperforming the benchmark by 3bps and delivered 3.33% in the 12-months period ending 31 December 2023, outperforming the benchmark by 38bps.

Headline inflation eased to 1.5% YoY in November (Oct: 1.8%), marking a sustained deceleration since September 2022 to a 33-month low. The reading came in below market consensus of 1.7%. The faster pace of deceleration was mainly due to lower gains in the food & non-alcoholic beverages subcomponents. Core inflation also eased to 2.0% (Oct:2.4%).

Malaysia's labour market kept a steady pace with the unemployment rate holding at 3.4% for the fifth straight month amid a continued uptrend in total employed persons (+0.2% m/m to 16.4 million) and increased labor force (+0.1% m/m to 16.97 million).

Malaysia's industrial production index (IPI) recovered to expand by 2.7% in October 2023, after reporting a 0.5% contraction the month prior, led by the improved performance of sector, and continuous growth in electricity and manufacturing sector's output.

We limit our investment exposure to short-term deposit placements due to the very low risk nature of the Fund.
