PERFORMANCE RECORD

The Fund feeds into Affin Hwang Select Asia (ex Japan) Quantum Fund ("target fund") with the objective to achieve consistent capital appreciation over medium to long-term by investing mainly in growth companies in Asia (ex Japan) with market capitalization of not more than USD1.5 billion at the time of acquisition, subject to the flexibility of investing up to 30% of the Net Asset Value (NAV) of the Fund in companies in Asia (ex Japan) with market capitalization of not more than USD3.0 billion at the time of acquisition.

FUND MANAGER'S COMMENTS

- Global equities dipped in September, with the S&P 500 index down 6.0%, whilst the Nasdaq Composite index plunged 7.7% as a tech rout deepened. President Trump's COVID-19 diagnosis injected fresh uncertainty to the US elections with investors already on edge trying to evaluate the possible outcomes.
- In Asia, the broader MSCI Asia ex-Japan index was down 1.5% in September, as the Hong Kong Hang Seng index closed 6.4% lower amidst profit taking ahead of the Golden Week holidays in China.
- This was despite positive data released in the month, with Chinese industrial output accelerating in August, up 5.6%, to spark a jump in the yuan to a 16-month high. Retail sales in China also grew for the first time this year.
- Singapore's export growth increased in August, supported by demand from China and increased electronic goods export
- The local market mirrored regional weakness with the benchmark KLCI falling 2.4% in October as political uncertainty dampened sentiment and a surge in COVID-19 cases in the country sent jitters to investors.
- **STRATEGY**: With the US Federal Reserves maintaining its dovish bias and keeping liquidity taps flowing, we see support for risk assets continuing. Hence, we remain positive on our tech holdings which continue to see strong growth.
- The fund remains highly invested as we do not think the current market correction will be protracted. The correction is healthy as sentiments and valuations on certain sectors were becoming excessive.
- Currently tilted more towards the healthcare and consumer sector with exposure at 22% and 24% respectively. Country allocation will be tilted towards Malaysia and China.
