PERFORMANCE RECORD

The Fund feeds into Affin Hwang Select Asia (ex Japan) Quantum Fund ("target fund") with the objective to achieve consistent capital appreciation over medium to long-term by investing mainly in growth companies in Asia (ex Japan) with market capitalization of not more than USD1.5 billion at the time of acquisition, subject to the flexibility of investing up to 30% of the Net Asset Value (NAV) of the Fund in companies in Asia (ex Japan) with market capitalization of not more than USD3.0 billion at the time of acquisition.

FUND MANAGER'S COMMENTS

- Global markets treaded cautiously on the back of second wave fears which sparked renewed concerns over the possibility of lockdowns being imposed again. The S&P 500 index was barely unchanged at 0.9% in June.
- In Asia, the broader MSCI Asia ex-Japan index closed 6.2% higher, while the Hong Kong Hang Seng Index rose 6.5%, amidst escalating tensions between the US and China.
- In China, economic activity steadied in June. Manufacturing PMI stood at 50.9 in June and non-manufacturing PMI at 54.4, up from 53.6 in May. This marked the fastest growth since November 2019.
- The local market ended on a softer note with the benchmark KLCI up 1.9% in June. Profit taking activities dragged down local equities, while retail investors continue to push up the daily trading volume to record highs.
- STRATEGY: The fund deployed some of its cash holdings in June, bringing invested levels to 97%.
- The fund is still overweight equities in the Hong Kong/China region as economic indicators are improving. Markets are now experiencing an optimistic V-shaped recovery as sentiments begin to improve.
- Key transactions in the month included adding some positions into the healthcare and technology space given its potential for significant growth and resiliency.
