Amidst increasing evidence that the global economy is slowing down, we are beginning to see signs that tightening measures from the Developed Markets, especially the US, may be near its end. This dynamic should result in yields on the longer end of the yield curve coming down. As such, we are lengthening duration to 5.5 to 6.0 years while remaining invested in liquid papers
