FUND MANAGER'S COMMENTS

- The global economy is expected to experience a soft landing in 2024, with growth projected at 3.1% according to the IMF. China's growth target is also likely to be set around 5%, while India is showing strong GDP growth.
- Central banks acknowledge rates are at reasonable level and will let it run its course with aggressive policy tightening behind us. The higher for longer narrative remains amidst mixed economic data. Nevertheless, market still factors in 3 interest rate cuts with first rate cut of 25bps expected in June 2024. Hence, with developed markets approaching peak cycle, risk appetite is expected to return to the Emerging Market space. Expect inflation to continue trending downwards although may take some time to reach 2%.
- We maintain our positive outlook for fixed income asset class in 2024, as global growth is expected to remain sanguine. We expect volatility to persist, but at a tighter range compared to 2023. The second half of 2024 may present higher noise as political uncertainties increase on the back of large number of elections especially the US Presidential election in Nov 2024.
- Domestically, moderating growth and contained inflation continued to be supportive of the fixed income market.
 Supportive technical, driven by lower government bond supply profile in 2024 due to fiscal consolidation is also a positive factor to the market. Domestic liquidity is ample with demand from duration coming from pension funds and lifers. Nevertheless, we are mindful of upside risks to inflation on the back of readjustment of subsidies.

STRATEGY:

- Selective participation in corporate bond/sukuk issuances is considered for potential yield gains.
- Current view is to stay neutral or lengthen duration in view of weakening growth environment and as global rate hike cycle come to a halt.
- Credits continue to contribute to the portfolio with the high IG tilt and continue to stay positioned in IG for the carry. Top contributor to performance comes from banks which continue to be actively issuing in the market.
- Foreign currency exposure has increased marginally again over the month as absolute yields here remain quite attractive. In addition, local currency Mexican Bonos position contributed strongly to performance during the month..

RISKS

Market risk

Credit and default risk

Credit risk relates to the credit worthiness of the issuers of the bonds or money market instruments ("Investment") and their expected ability to make timely payment of interest and/or principal. Any adverse situations faced by the issuer may impact the value as well as liquidity of the Investment. In the case of rated investment, this may lead to a credit downgrade. Default risk relates to the risk of an issuer of the Investment either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the Investment. This could adversely affect the value of the target fund.

Interest rate risk

This risk refers to the impact of interest rate changes on the valuation of bonds or money market instruments ("Investment"). When interest rates rise, the investment prices generally decline and this may lower the market value of the Investment. The reverse may apply when interest rates fall.

Currency risk

As the Investments of the target fund may be denominated in currencies other than the base currency, any fluctuation in the exchange rate between the base currency and the currencies in which the investments are denominated may have an impact on the value of these investments. Investors should note that any gains or losses arising from the fluctuation in the exchange rate may further increase or decrease the returns of the investment.

Currency risk at the target fund level

The impact of the exchange rate movement between the base currency of the target fund and the currency of the underlying investments may result in a depreciation of the value of the investments as expressed in the base currency of the target fund.

Structured products risk

For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or prices of units to fall.

Regulatory risk

The investments of the target fund would be exposed to changes in the laws and regulations in the countries the target fund is invested in. These regulatory changes pose a risk to the target fund as it may materially impact the investments of the target fund. In an effort to manage and mitigate such risk, the fund manager seeks to continuously keep abreast of regulatory developments (for example, by closely monitoring announcements on regulators' website and mainstream media) in that country. The fund manager may dispose its investments in that particular country should the regulatory changes adversely impact the investors' interest or diminish returns to the target fund.
