PERFORMANCE RECORD

This fund feeds into Principal Islamic Aggressive Wholesale Fund-of-Funds ("target fund") with the objective to achieve capital growth by investing in a portfolio of Shariah-compliant collective investment schemes that invest primarily in Shariah-compliant equities.

FUND MANAGER'S COMMENTS

The Fund fell 0.67% during the month, underperforming the benchmark by 0.21ppt as the Islamic Index fell 5.6% in US\$ terms in April, led by Taiwan, Singapore and China while Indonesia outperformed. The US 10-year bond yield rose meaningfully by 60bps to 2.94% and the Dollar Index appreciated 4.7% during the month as we approach the Fed's much anticipated rate hike in May.

With the US Federal Reserve commencing its interest rate hike cycle, most Asian central banks would have to follow a similar path or risk weakness in their currencies. Indeed, the Reserve Bank of India and Reserve Bank of Australia had recently raised rates in tandem. The resultant economic growth path in reaction to the rate hike cycle would be keenly watched.

In China, the government's strict zero Covid strategy has impacted business activities such as observed in Shanghai and Beijing, causing widespread implications on various supply chains. President Xi announced the intention to step up on infrastructure spending to support the economy towards the end of the month and there were also expectations of easing crackdown on internet companies. We remain selective in China, such as beneficiaries of decarbonization or winners of policy easing, etc.

We are fully invested and plan to diversify our holdings across businesses and geographies to improve our portfolio's resilience. We are recalibrating our positions in selected technology hardware names where growth is more sensitive to the global economic environment. Off-benchmark stocks contribute ~40% to our portfolio.

RISKS

If this occurs, Principal will take the necessary steps to dispose of such securities. Shariah status risk There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event that the Shariah non-compliant securities are disposed of at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund or price of units to fall. Since the target fund will invest entirely into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and Risk associated with management. In the event of mismanagement of the Islamic CIS and/or the management investing in Islamic CIS company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund. The target fund may invest into Islamic CIS which can be domiciled in various countries. Therefore, the target fund will be subjected to risks specific to the countries in which the Islamic CIS are domiciled. Such risks include adverse changes in economic fundamentals, **Country risk** social and political stability, laws and regulations and foreign investments policies. These

factors may have an adverse impact on the price of the Islamic CIS, which will depress the

Islamic CIS's NAV growth, and consequently depress the target fund's NAV growth.
