FUND MANAGER'S COMMENTS

The Fund increased by 5.85% during the month, underperforming the benchmark by 4.21ppt.

Global stocks experienced heightened volatility in March due to banking turmoil in the United States and Switzerland. However, fairly quick action by authorities in both countries to stem potential contagion reassured many investors, driving global stocks higher. As measured by MSCI indices in US-dollar terms, developed market equities modestly outperformed a global index, while emerging and frontier market equities substantially underperformed it.

We are monitoring risks including the collapse of two US mid-sized banks and the impact on technology-related and financial services industries; we anticipate incremental caution around IT budgets at technology companies that relied on these banks for capital, and regional banks that may have to prepare for risks to deposits or loan activity.

We continue to believe digital transformation (DT) is a multi-trillion-dollar opportunity as it enables a widening array of companies to leverage software and data to better understand their customers and business processes, as well as various technologies to radically transform how they operate. Furthermore, with evidence that DT drives improved productivity and deeper customer relationships, we believe companies are now operationalising and scaling what worked during the COVID crisis and extending their DT initiatives into other parts of their operations.
