FUND MANAGER'S COMMENTS

The Fund increased by 3.34% during the month, underperforming the benchmark by 0.69ppt.

Global equities collectively ended January 2024 with slight gains despite bouts of volatility as investors reassessed their expectations of interest rate cuts in the United States and Europe amidst pushback from the US Federal Reserve (Fed) and the European Central Bank. Information technology (IT) and communication services were the two top-performing equity sectors, in the United States and globally. IT returns varied greatly and were strongest amongst semiconductor-related companies. Software stocks also saw above-average gains, while computer hardware and electronic equipment makers generally sold off. Communication services sector equities were more closely linked as all five related industries advanced together.

We acknowledge that sector valuation has increased over the past year, but we continue to see opportunities, particularly down the market-cap spectrum across several IT and communications services industries. We are currently overweighted in small- and mid-cap stocks and underweighted in mega caps. For the high-growth IT sector, disinflation and stable or declining US Treasury yields are generally supportive of valuation, and we continue to assume a fairly stable yield environment in 2024.
