FUND MANAGER'S COMMENTS

For the month, the fund gained 0.67 bps (basis points) in MYR terms, outperforming the benchmark by 65 bps. For the year-to-date performance, the fund is outperforming thebenchmark by 122 bps benefitted from the underweight positioning in Malaysia Banks.

The KLCI fell 2.9% in October as investors risk-off ahead of the US elections, despite the Fed very likely to cut another 25 bps in the November FOMC meeting given the recentinflation print and weak jobs data. Utilities and Telcos were sold off the most, while Construction, REITs and Healthcare posted modest gains.

Other key benchmarks: CPO surged 22% to c.RM4,900/t, Brent was up 2% at ~US\$73/bbl. Ringgit weakened 6% against the Dollar at RM4.378, while the 10Y MGS yields rose 21 bpsto 3.921.

The KLCI is now trading at a forward PE of under 14X, which is at -1SD below the 10-year historical mean, but still more than 2SD below pre-Covid19 mean of 16X. Consensusprojects earnings growth for FBM30 of 8-9% for 2024 and 2025. Sustained strength in domestic investments (both DDI and FDI), fiscal consolidation gathering pace (in particular, subsidy rationalisation initiatives) and the strengthening of the Ringgit are factors we see supportive of the further narrowing of risk premiums (current yield gap at -330 bps; pre-Covidaverage of 230 bps) and consequently higher valuation multiples.

MSCI AC Asia Pacific ex Japan Index reverses some of the rally seen in September, ending 4.72% lower. The worst performing market was India, with MSCI India declining 7.44% during the month on the back of fears of overvaluation in the market as a whole. China was the next worst market, giving back a lot of the recent gains that we saw there previously. The momentum of belief in the stimulus by the government is waning and we saw a significant amount of outflow throughout October. Taiwan was the bright spot in North Asia, returning a 3.87% during the month.

We have a positive view on Asian equities, given the attractive investment themes. We still like the tech sector as we see semiconductor investments continuing to grow into next yearwhile expectations have been lowered. We will continue to diversify and position the portfolio in areas where they are likely to print strong earnings growth such as the semiconductorindustry, beneficiaries of Al spend, and Korea value up program, rising consumer discretionary spent or rising capex. We have been taking some profits off from our China names as wesee risk of disappointment in relation to stimulus going into 2025.

Stock specific risk

We aim to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.

Interest rate risk

Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments.

Country risk

Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall.

Currency risk
