FUND MANAGER'S COMMENTS

- Global equities treaded higher in April amidst a slew of data releases and earnings results. The MSCI AC World index closed 4.4% higher, while the Nasdaq rose 5.5% as technology stocks reported stellar earnings.
- Local markets treaded cautiously with the KLCI inching 1.8% higher as rising COVID-19 cases sparked fears of another movement control order ("MCO").
- The big 4 glove players saw notable gains in the past month, following record earnings seen by some companies driven by higher average selling prices and amidst speculations of an imminent lifting of the US CBP suspension on Top Glove. Skepticism towards the AstraZeneca vaccine and the emergence of a new covid-19 variant also lent strength to the glove rally.
- Malaysia reported strong trade numbers in March with exports beating consensus at +31.0% (+22.9% consensus) while imports surged +19.2% (+17.2% consensus) aided by economic recovery, vaccine rollout and higher commodity prices, on top of low base effect.
- A revised alignment to ECRL3.0 back to the initial northern alignment proposed back in 2017 was announced, reducing estimated costs for the project. The timeline for project completion remains unchanged. Potential jobs to local contractors is not expected to see meaningful alterations. Meanwhile, scheduling for the tender for the MRT3 Circle Line is expected to be sometime in August.
- **STRATEGY:** The fund's invested levels was raised to 98% during the month. The fund remains positioned in quality large-cap Shariah-compliant stocks in the domestic market.
- Accommodative policies, strong liquidity conditions and the vaccine rollout are expected to provide support for stock markets. Hence, we look to be highly invested.
- The Fund's largest sector exposure is in exporters (tech and EMS sector) due to a strong growth outlook, and a beneficiary of trade diversion. Other major exposure includes telco names, which benefits from 5G rollout and MyDigital initiative.
- We take a longer term view by holding on to recovery-plays including banks, commodities, consumer and hospitality despite recent resurgence in Covid-19 cases. We also took a trading view on the gloves sector.
- Politics remains a key risk. Despite political still an overhang and may last until end of emergency period. Meanwhile, markets are likely to focus on economic recovery and vaccine rollout.
- Over the month, we took profit on some construction and financial sector names following strong performance. We also added to some names within the EMS tech and consumer sector.
- The fund continues to adopt a barbell strategy, invested in re-opening beneficiaries and companies with long term structural growth opportunities.

Market risk	Market risk arises because of factors that affect the entire marketplace. Factors such as economic growth, political stability and social environment are some examples of conditions that have an impact on businesses, whether positive or negative. Fund management risk	This risk refers to the day-to-day management of the target fund by Affin Hwang which will impact the performance of the target fund. For example, investment decisions undertaken by Affin Hwang as a result of an incorrect view of the market or any non-compliance with internal policies, investment mandate, the deed, relevant law or guidelines due to factors such as human error, fraudulence, dishonesty or weaknesses in operational process and systems, may adversely affect the performance of the target fund.

Inflation risk	This is the risk that your investment in the target fund may not grow or generate income at a rate that keeps pace with inflation. This would reduce your purchasing power even though the value of the investment in monetary terms has increased.
Liquidity risk	Liquidity risk arises in two scenarios. The first scenario is where the target fund's investment cannot be sold due to unavailability of a buyer for that investment. The second scenario exists where the target fund's investment, by its nature, is thinly traded. This will have the effect of causing the target fund's investment to be sold below its fair value which would adversely affect the NAV of the target fund.
Credit/Default risk	Credit risk relates to the creditworthiness of the issuers of the investment (Islamic money market instruments) and their expected ability to make timely payment of interest and/or principal. Any adverse situations faced by the issuers may impact the value as well as liquidity of the investment. In the case of rated investments, this may lead to a credit downgrade. Default risk relates to the risk of an issuer of the investment either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investment. This could adversely affect the value of the target fund.
Equity investment risk	This is the risk associated with investing in a particular equity. The value of individual equity is mainly determined by its potential growth in earnings, sound management, and treatment of minority shareholders, as well as a myriad of other factors. Failure to achieve these would result in declining investment value which in turn affects the performance of the target fund. This can be mitigated by diversifying the target fund's portfolios.

RISKS (CONTINUED)

Reclassification of Shariah status risk

This risk refers to the risk that the currently held Shariah-compliant securities by the target fund may be reclassified to be Shariah non-compliant in the periodic review of the equities by the Shariah Advisory Council of the Securities Commission Malaysia (SACSC), the Shariah Adviser for the target fund or the Shariah boards of the relevant Islamic indices.

If this occurs, Affin Hwang will take the necessary steps to dispose of such equities. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess capital gains derived from the disposal of the Shariah non-compliant equities. Affin Hwang will be required to dispose of these equities immediately if the prices are above the purchase price. Should the prices be below the purchase price, Affin Hwang may choose to hold on to these holdings until the prices meet the purchase price. Nevertheless, should Affin Hwang decide to dispose of these equities below the purchase price, the target fund will be faced with the risk of realising its losses, thus negatively impacting the NAV of the target fund.

Shariah-compliant warrants investment risk

The value of the Shariah-compliant warrants (“warrants”) will depend on the pricing of the underlying security whereby the growth and performance prospect of the underlying security would consequentially affect the value of the warrants. In addition, the value of the warrants may decrease exponentially as the warrants approach its maturity date and the potential gains from a favourable price movement of the underlying security may be offset by aggressive time decay. Affin Hwang may consider unwinding these warrants if there are material adverse changes to its value with the aim to mitigate the risk.
