PERFORMANCE RECORD

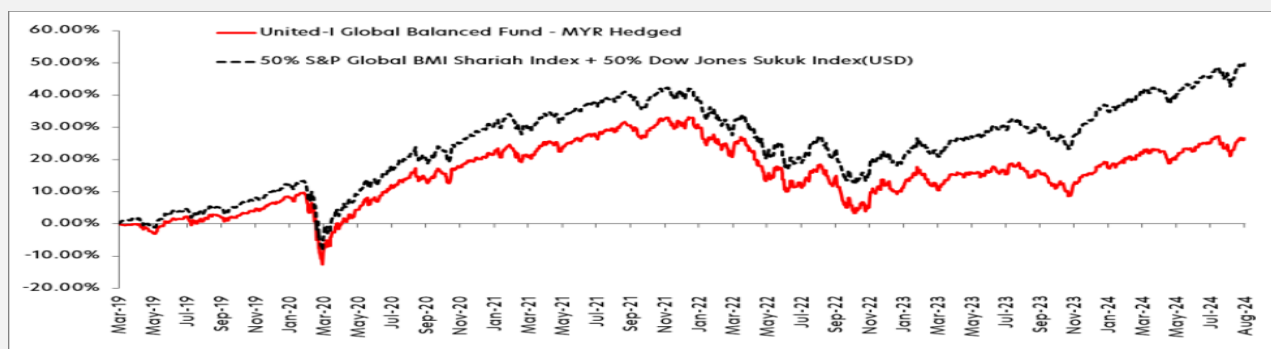

FUND MANAGER'S COMMENTS

Equity

The portfolio modestly outperformed the index over the period. Strong selection in information technology and health care was partially offset by selection in consumer discretionary and consumer staples. On a regional basis, strong stock selection in Emerging Markets and United Kingdom was modestly offset by selection in Developed EU & Middle East ex UK and Developed Asia Pacific ex Japan.

Within information technology and health care, our top relative contributors were overweights to ASPEED Technology and Eli Lilly, respectively. Within consumer discretionary and consumer staples, our top relative detractors were overweights to Amazon.com and Celsius, respectively.

Shares of ASPEED Technology rose over the period after the fabless integrated circuit design company released first half results where net income came in above estimates. The company also increased revenue guidance for the remainder of the year, citing rising global demand for AI servers as a driver for sales of their baseboard management controllers. Shares of Amazon fell after the e-commerce giant reported mixed results for the second quarter. Earnings beat expectations and revenue missed consensus estimates due to cautious consumers choosing to trade down to lower-priced products. Management issued disappointing guidance for the third quarter, citing challenging consumer environment.

Sukuk

The sukuk sleeves outperformed its benchmark by 80bps (Sukuk return: 2.80 vs Benchmark: 2.00), driven by government agency sector. Contributor of the fund was Perusahaan Penerbitan SBSN while detractor of fund was Malaysia sovereign sukuk.

Reclassification of Shariah non-compliant status Risk	This risk refers to the risk that the currently held Shariah-compliant securities in the target fund may be reclassified as Shariah non-compliant in the periodic review of the securities by the Shariah Advisory Council of the Securities Commission Malaysia (SACSC), the Shariah adviser or the Shariah boards of the relevant Islamic indices. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event the Shariah non-compliant securities are disposed at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund to fall.
Credit and Default Risk	<p>Credit risk relates to the creditworthiness of the issuers of Sukuk, Islamic money market instruments and/or financial institutions where the Islamic deposits are placed and their expected ability to make timely payment of profit and/or principal. Any adverse situations faced by the issuer of the Sukuk, Islamic money market instruments and /or financial institutions where the Islamic deposits are placed may impact the value as well as liquidity of the Sukuk, Islamic money market instruments and/or Islamic deposits. Interest Rate Risk	Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and/or Islamic money market instruments. When interest rates rise, Sukuk and/or Islamic money market instruments prices generally decline and this may lower the market value of the target fund's investment in Sukuk and/or Islamic money market instruments. The reverse may apply when interest rates fall. Meanwhile, Sukuk and/or Islamic money market instruments with longer maturities and lower profit rates are more sensitive to interest rate changes.

Equity Risk

As the target fund will be investing in Shariah-compliant equities, the target fund will be affected by equity risk. Generally, equity risk may arise in the following forms, i.e., equity risks related to external factors and equity risks related to company-specific factors. All of these related equity risks can adversely affect the prices of equities, which would negatively impact the performance of the target fund.

Country Risk

The target fund is also subject to country risk. The value of the assets of the target fund may also be affected by the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund may invest in. Further, when investing in foreign markets, there are countries which may require prior approvals before investments can take place.
