## FUND MANAGER'S COMMENTS

- Global equities wobbled in November as markets contend with a possibly muddled outlook of decelerating growth as well as tightening bets by the US Federal Reserve. The MSCI AC World Index was down 2.4% while the S&P 500 closed 0.7% lower during the month.
- Local markets mirrored the weakness in regional equities, with the FBM100 index down 3.8% in November. The emergence of the Omicron variant raised concerns of the reimposition of movement controls.
- Malaysia's economy contracted 4.5% y-o-y in the 3Q 2021, amid the strict Covid-19 containment measures in July, which weighed on consumption and investments. However, monthly GDP estimates show that the impact of the containment measures was tapering as restrictions were eased in a phased manner throughout the quarter.
- Local companies were further beseeched by ESG headwinds, this time within the technology sector where a few electronic manufacturing Service ("EMS") companies faced allegations of forced labour.
- Barisan Nasional won a landslide victory at the Melaka state polls garnering a 2/3 majority to form the next state government. This was seen as a bellwether of what could play out in the 15th General Election.

### STRATEGY:

- The fund's invested levels remained at 96% during the month. The fund remains positioned in quality large-cap Shariah-compliant stocks in the domestic market.
- The one-off prosperity tax (Cukai Makmur) announced in Budget 2022 would wipe out a big part of earnings growth. For markets to move higher, we would need to see a successful rollout of Covid treatment and a return of foreign workers for the manufacturing sector.
- Local equities had been one of the worst performing market in the region after HK/China - limited downside at current level. We look to remain highly invested, riding through near term volatility from any knee jerk reactions to the prosperity tax.
- Fears that the Omicron variant of Covid roiled market, with concerns that movement restrictions could be reimposed. However, while it could be more transmissible, evidence suggest that symptoms are mild and that the Pfizer treatment has 90% efficacy. We will continue to assess our fund positioning as we get more clarity on Omicron. A relatively high vaccination rates with new Covid cases trending lower is a positive development and bodes well for a recovery in economic activities. We are well positioned for this with a focus on by recovery beneficiaries (e.g. banks, consumer).
- We are positive on fixed line telco names following various digitalisation initiatives, covering 5G rollout and migration to cloud. We also favour exporters, particularly tech and EMS companies riding on secular growth trends and benefits from the US-China trade divergence.

For example, investment decisions undertaken by Affin Hwang as a result of an incorrect view of the market or any non-compliance with internal policies, investment mandate, the deed, relevant law or guidelines due to factors such as human error, fraudulence, dishonesty or weaknesses in operational process and systems, may adversely affect the performance of the target fund.
<b>Performance risk</b>	There is no guarantee in relation to the investment returns.
<b>Inflation risk</b>	This is the risk that your investment in the target fund may not grow or generate income at a rate that keeps pace with inflation. This would reduce your purchasing power even though the value of the investment in monetary terms has increased.
<b>Liquidity risk</b>	Liquidity risk arises in two scenarios. The first scenario is where the target fund's investment cannot be sold due to unavailability of a buyer for that investment. The second scenario exists where the target fund's investment, by its nature, is thinly traded. This will have the effect of causing the target fund's investment to be sold below its fair value which would adversely affect the NAV of the target fund.
<b>Credit/Default risk</b>	Credit risk relates to the creditworthiness of the issuers of the investment (Islamic money market instruments) and their expected ability to make timely payment of interest and/or principal. Any adverse situations faced by the issuers may impact the value as well as liquidity of the investment. In the case of rated investments, this may lead to a credit downgrade. Default risk relates to the risk of an issuer of the investment either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investment. This could adversely affect the value of the target fund.
<b>Equity investment risk</b>	This is the risk associated with investing in a particular equity. The value of individual equity is mainly determined by its potential growth in earnings, sound management, and treatment of minority shareholders, as well as a myriad of other factors. Failure to achieve these would result in declining investment value which in turn affects the performance of the target fund. This can be mitigated by diversifying the target fund's portfolios.

**Reclassification of Shariah status risk**

This risk refers to the risk that the currently held Shariah-compliant securities by the target fund may be reclassified to be Shariah non-compliant in the periodic review of the equities by the Shariah Advisory Council of the Securities Commission Malaysia (SACSC), the Shariah Adviser for the target fund or the Shariah boards of the relevant Islamic indices.

If this occurs, Affin Hwang will take the necessary steps to dispose of such equities. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess capital gains derived from the disposal of the Shariah non-compliant equities. Affin Hwang will be required to dispose of these equities immediately if the prices are above the purchase price. Should the prices be below the purchase price, Affin Hwang may choose to hold on to these holdings until the prices meet the purchase price. Nevertheless, should Affin Hwang decide to dispose of these equities below the purchase price, the target fund will be faced with the risk of realising its losses, thus negatively impacting the NAV of the target fund.

**Shariah-compliant warrants investment risk**

The value of the Shariah-compliant warrants (“warrants”) will depend on the pricing of the underlying security whereby the growth and performance prospect of the underlying security would consequentially affect the value of the warrants.
