FUND MANAGER'S COMMENTS

The Fund increased by 5.18% in November, underperforming the benchmark by 101 bps. YTD, the Fund is up 18.83%, underperforming the benchmark by 265 bps.

S&P500, MSCI Europe and MSCI Japan declined by 2.2%, 3.6% and 3.1% respectively MTD in local currency terms with rising bond yields. The 10-year Treasury bond yield moderated to 4.7% at the time of writing. With headline inflation peaked in US and Europe, the Fed and the ECB paused its rate hikes during its November policy meeting. The Bank of Japan (BOJ) further moderated YCC and made 1% upper cap of 10-year JGB yield as a reference while maintaining an accommodative bias. All three currencies, U.S. Dollar, Euro and Japanese Yen appreciated by 0.5%, 0.02% and 1.6%, respectively, at the time of writing.

Manufacturing PMIs are in the contraction zone across developed markets, partially because of subdued demand from China. Furthermore, Services PMIs have begun to decline in both the U.S. and Europe. More indicators pointed to a cooling US labor market: Nonfarm payrolls increased by 150k for October, below the consensus forecast of 170k. Unemployment rate rose to 3.9%, highest since February 2022. Wage growth further moderated with MoM Average Hourly Earnings at 0.2%. Forward 12-month corporate earnings have been revised up for all developed markets with MSCI Japan seeing the highest earnings revision.

Strategy: Underweight US and Europe, Overweight Japan. Disinflationary pressures coupled with robust economic activity have created a more constructive US narrative. However, elevated valuations and restrictive monetary policy suggest further limited upside for US equity. Europe is decoupling from the broad bullish market sentiment. The deteriorating economic backdrop suggests possible downward revisions in earnings ahead. On the other hand, Japan's economy is strengthening, driving inflation and wage pressures to a healthier level. The BOJ has resisted a meaningful monetary policy shift, resulting in a continued weakening of the Japanese Yen, which is supporting corporate earnings. Furthermore, Japan provides an element of diversification given its cycle appears desynchronized from other developed markets.
