#### FUND MANAGER'S COMMENTS

During the month, our Fund rose +0.25% in MYR terms, underperforming the benchmark by 155 basis points (bps) mainly due to Taiwan. Year-to-date, our Fund declined 8.% in MYR terms, underperforming the benchmark by 217bps.

After strict lockdowns over the past few months across various cities under its Covid zero policy, China appears to be changing its approach and relaxing mobility restrictions such as that observed in Shanghai. The emergency meeting by Chinese premier Li Keqiang to thousands of local officials could be seen as an important development whereby the negative effects from drastic lockdowns need to be taken into consideration. Meanwhile, China continues to ease with PBOC reducing the five-year loan prime rate, a reference for mortgages. As the Fed begins its policy rate normalization with half a percentage point raise in May, most Asian central banks would have to follow a similar path or risk weakness in their currencies. Indeed, the Reserve Bank of India, Reserve Bank of Australia and Bank Negara Malaysia had recently raised rates in tandem. The resultant economic growth path in reaction to the rate hike cycle would be keenly watched. We are fully invested and plan to diversify our holdings across businesses and geographies to improve our portfolio's resilience.

We are turning slightly more positive in Asian equities. We remain fully invested and diversified across sectors and geographies. Characteristics like quality, earnings resilience, growth visibility and reasonable valuations are favored.

This in turn may cause the NAV of the target fund or price of units to fall.
<b>Currency risk</b>	As the investments of the target fund may be denominated in currencies other than the base currency of the target fund, any fluctuation in the exchange rate between the base currency of the target fund and the currencies in which the investments are denominated may have an impact on the value of these investments. You should be aware that if the currencies in which the investments are denominated depreciate against the base currency of the target fund, this will have an adverse effect on the NAV of the target fund in the base currency of the target fund and vice versa. You should note that any gains or losses arising from the fluctuation in the exchange rate may further increase or decrease the returns of the investment.
<b>Risks associated with investment in warrants and/or options</b>	There are inherent risks associated with investment in warrants and/or options. <b>Credit/Default risk</b>	The target fund will be exposed to a certain degree of credit and default risk of issuers or counterparties when the target fund invests in Sukuk and/or place Islamic deposits. Credit risk relates to the creditworthiness of the securities issuers or counterparties and their expected ability to make timely payment of profit and/or principal. Any adverse situations faced by the issuers or counterparties may impact the value as well as liquidity of the investments. In the case of rated Sukuk, this may lead to a credit downgrade. Default risk relates to the risk that a securities issuer or counterparty either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investments. This could adversely affect the value of the target fund. Principal aims to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.

**RISKS (CONTINUED)**

**Interest rate risk**

Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and Islamic money market instruments. When interest rates rise, Sukuk and Islamic money market instruments' prices generally decline and this may lower the market and Islamic money market instruments. In managing the Sukuk, Principal takes into account the coupon rate and time to maturity of the Sukuk with an aim to mitigate the interest rate risk. As for Islamic money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike Sukuk, any change to interest rate will only have a minor impact to the prices of these instruments.

Note: Please note that although Sukuk is a non-interest bearing instrument, its price movement is correlated to the movement in the interest rates. As such, investment in Sukuk will have an exposure to the movement of the interest rates. Even though the target fund does not invest in interest bearing instruments, the interest rate referred herein is to the general interest rate of the country, which may affect the value of the investment of the target fund.

**Risk associated with investing in CIS**

Since the target fund may invest into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.
