FUND MANAGER’S COMMENTS

The Fund delivered 0.21% in the month of March 2020, underperforming the benchmark by 2bps, and delivered 2.62% in the 12-months period ending 31 March 2020, underperforming the benchmark by 0.39%.

We limit our investment exposure to short-term Islamic deposit placements due to the very low risk nature of the Fund.
