

FUND MANAGER'S COMMENTS

The Fund fell 0.12% during the month, underperformed the benchmark by 0.86%.

During the fourth quarter of 2024 (4Q24), global stocks were pressured by investor concerns about economic growth, persistent inflation in some regions and the likelihood of furtherinterest-rate cuts in 2025. Global manufacturing activity contracted in December after stabilising in November, while global services activity expanded in November for the 22ndconsecutive month and flash reports for December showed continued strength in many regions. IT ended 2024 in a virtual tie with communication services as the top-performing sectorglobally. Broadly, IT companies were above average in terms of 3Q24 sales and earnings growth, with the majority of them topping analysts' consensus estimates on both counts. Artificial intelligence (AI) adoption and demand-related data continue to strengthen along with the AI capital expenditure (capex) trajectory, with many companies working in the Alspace reinforcing their plans for higher levels of spending going forward as the risk of underinvesting is generally deemed much greater than the risk of overinvesting. Nonetheless, occasionally mixed economic and corporate earnings signals kept investors cautious throughout 4Q24.

We believe we could see another strong year of earnings growth in 2025, driven by a steady progression up the GenAl adoption curve, an improving earnings growth trajectory outside of the "Magnificent Seven," a group of leading technology-focused companies, and what we consider reasonable valuations on an earnings growth-relative basis. At year-end 2024, theIT sector's price/earnings-to-growth (PEG) ratio was just slightly above the five-year average.
