## FUND MANAGER’S COMMENTS

The Fund delivered 0.12% in the month of December 2020, underperforming the benchmark by 3bps, and delivered 1.98% in the 12-months period ending 31 December 2020, underperforming the benchmark by 20bps.

We limit our investment exposure to short-term Islamic deposit placements due to the very low risk nature of the Fund.
