## PERFORMANCE RECORD

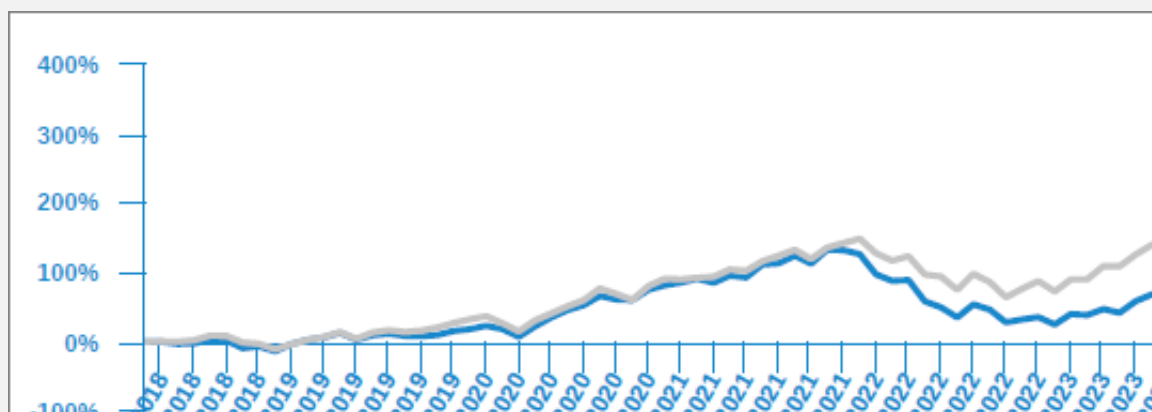

## FUND MANAGER'S COMMENTS

The Fund fell 2.03% during the month, outperformed the benchmark by 3.18%

In November 2024, global equities experienced consecutive losses, though U.S. stocks rallied significantly following Donald Trump's presidential victory. Optimism about potential taxcuts and expansionary fiscal policies fueled gains in U.S. equities, while global investors were more cautious due to concerns over potential tariffs and their impact on trade. Manufacturing activity showed signs of recovery, stabilizing after months of contraction. Developed markets outperformed global benchmarks, while emerging and frontier markets underperformed. Growth stocks led value stocks, with the information technology (IT) sector delivering notable returns, driven by strength in IT services and software industries, though semiconductor-related and electronic equipment industries lagged.

Globally, IT remained the top-performing sector of 2024, though its lead narrowed amid valuation concerns. In the U.S., IT ranked third behind financials and communication services. The communication services sector posted below-average gains, supported by strong entertainment stocks but weighed down by weaker interactive media performance. Overall, this sector benefited from robust advertising and subscription revenues.

As for the hedged class, the class itself provides mitigation to the currency risk arising from the difference between the currency denomination of the class and the base currency. <b>Manager's risk</b>	Since the target fund invests into a collective investment scheme (CIS) managed by another manager, the master fund's manager has absolute discretion over the target fund's investment technique and knowledge, operational controls and management. In the event of mismanagement of the master fund, the NAV of the target fund, which invests into the master fund would be affected negatively.
<b>Country risk</b>	As the target fund invests in the master fund which is domiciled in Luxembourg, the target fund's investments in the master fund may be affected by risks specific to Luxembourg. Changes to laws and regulations of Luxembourg may have an adverse impact on the master fund, and consequently the target fund.
