PERFORMANCE RECORD

This fund feeds into United-*i* Global Balanced Fund -MYR hedge Class ("target fund") with the objective to provide income and capital appreciation over the medium to long term by investing in Shariah-compliant equities and Sukuk globally.

FUND MANAGER'S COMMENTS

Equity

Strong selection in consumer discretionary, industrials and information technology was modestly offset by selection in materials. On a regional basis, strong stock selection in North America and Developed EU & Middle East ex UK was modestly offset by selection in Japan.

Within consumer discretionary and industrials, our top relative contributors were an underweight to Tesla and an overweight to Uber Technologies, respectively. Within materials and real estate, our top relative detractors were overweights to Vale and KE Holdings, respectively.

Shares of Tesla declined during the period due to weak earnings for Q4 2023, with profits falling 40% compared to the same quarter last year. The company initiated a series of price cuts on its cars, sending profit margins down significantly. The company's revenue of \$25.2 billion also came in below expectations. Shares of Vale ended the period lower. A federal Judge in Brazil ordered the Vale, Samarco and BHP to pay \$9.7 billion in damages for a 2015 tailings dam burst. Additionally, iron ore demand declined on slump in Chinese steel output.

Sukuk

The sukuk sleeves underperform its benchmark by 47bps (Sukuk return: 2.09 vs Benchmark: 2.56), driven by utility sector. Contributor of the fund was Penerbitan Perusahaan SBSB, while detractor of fund was Saudi Electric Co.

Reclassification of Shariah non-compliant status Risk	This risk refers to the risk that the currently held Shariah-compliant securities in the target fund may be reclassified as Shariah non-compliant in the periodic review of the securities by the Shariah Advisory Council of the Securities Commission Malaysia (SACSC), the Shariah adviser or the Shariah boards of the relevant Islamic indices. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event the Shariah non-compliant securities are disposed at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund to fall.
Credit and Default Risk	<p>Credit risk relates to the creditworthiness of the issuers of Sukuk, Islamic money market instruments and/or financial institutions where the Islamic deposits are placed and their expected ability to make timely payment of profit and/or principal. Interest Rate Risk	Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and/or Islamic money market instruments. When interest rates rise, Sukuk and/or Islamic money market instruments prices generally decline and this may lower the market value of the target fund's investment in Sukuk and/or Islamic money market instruments. The reverse may apply when interest rates fall. Meanwhile, Sukuk and/or Islamic money market instruments with longer maturities and lower profit rates are more sensitive to interest rate changes.

Equity Risk

As the target fund will be investing in Shariah-compliant equities, the target fund will be affected by equity risk. Generally, equity risk may arise in the following forms, i.e., equity risks related to external factors and equity risks related to company-specific factors. All of these related equity risks can adversely affect the prices of equities, which would negatively impact the performance of the target fund.

Country Risk

The target fund is also subject to country risk. The value of the assets of the target fund may also be affected by the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund may invest in. Further, when investing in foreign markets, there are countries which may require prior approvals before investments can take place.
