FUND MANAGER'S COMMENTS

During the month, our Fund declined 2.2% in MYR terms, underperforming the benchmark by 181 basis points mainly due to Information Technology, partially attributable to our structural underweight a benchmark name due to single stock limit constraints. Year-to-date, our Fund rose 3.9% in MYR terms, underperforming the Benchmark by 591 basis points. The Fund has outperformed its benchmark on a longer term basis over 5 years and since inception.

The US economy is strong and inflation sticky. The very gradual cooling in hiring and wage growth is partly why the US Fed is in no rush to cut policy rates. We think US 10-year yields are close to the peak and the next move in policy rates will be down. In Asia, we think China/ HK has bottomed given signals that more supportive property policies could be unveiled, the olive branch extended to foreign businesses (e.g., China Development Forum in March) and more friendly trade policy (scrapped tariffs on Australian wine in March). China's macro backdrop is complex and "noisy" with growth in some areas (manufacturing), softness in property sales and prices, and uneven confidence among corporates. We view any weakness in Asian assets due to "higher for longer US rates" as a buying opportunity.

We remain fully invested and well positioned in the areas of a) bottoming of the tech hardware cycle (DRAM memory, foundry, equipment) b) strong private sector confidence in India(consumption, property, industrials) c) selected global names with resilient demand in the areas of consumption (luxury retail, cosmetics) and technology software. During the month, we added selected companies in China in the areas of EV battery and industrial automation on the back of macro stabilization.

Credit risk relates to the creditworthiness of the securities issuers or counterparties and their expected ability to make timely payment of profit and/or principal. Any adverse situations faced by the issuers or counterparties may impact the value as well as liquidity of the investments. In the case of rated Sukuk, this may lead to a credit downgrade. Default risk relates to the risk that a securities issuer or counterparty either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investments. Principal aims to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.

Interest rate risk	Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and Islamic money market instruments. When interest rates rise, Sukuk and Islamic money market instruments' prices generally decline and this may lower the market and Islamic money market instruments. In managing the Sukuk, Principal takes into account the coupon rate and time to maturity of the Sukuk with an aim to mitigate the interest rate risk. As for Islamic money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike Sukuk, any change to interest rate will only have a minor impact to the prices of these instruments. Note: Please note that although Sukuk is a non-interest bearing instrument, its price movement is correlated to the movement in the interest rates. As such, investment in Sukuk will have an exposure to the movement of the interest rate referred herein is to the general interest rate of the country, which may affect the value of the investment of the target fund.
Risk associated with investing in CIS	Since the target fund may invest into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.
