

FUND MANAGER'S COMMENTS

The Fund decreased by 3.53% during the month, underperformed the benchmark by 1.48%.

Global equities collectively rose in July 2024 despite heightened volatility that included a rotation away from large-capitalisation technology related stocks worldwide especially thosefocused on artificial intelligence (AI). Cooler-than-expected inflation and a softening job market in the United States increased investor expectations for interest-rate cuts, leading to apreference for small-cap stocks, rate-sensitive equities and more cyclical areas of the market. After sitting at or near the top of the global sector rankings in May and June, informationtechnology (IT) and communication services were the worst performers in July and were the only two out of 11 equity sectors to record overall losses.

Following the July selloff, we still view the critical factors for the sector's return to outperformance in the broader equity market. A strategic imperative for businesses as they realise thevalue of improved efficiency and growth even in a mixed macroeconomic backdrop, GenAl proves its worth as the next computing paradigm, a more stable inflation and interest-rateenvironment and reasonable equity valuations on an earnings growth-relative basis.
