### PERFORMANCE RECORD

This fund feeds into Principal Asia Pacific Dynamic Income Fund ("target fund") with the objective to provide regular income by investing primarily in the Asia Pacific ex Japan region and at the same time aims to achieve capital appreciation over the medium to long-term.

#### FUND MANAGER'S COMMENTS

The Fund was up 5.90% in MYR terms in November, outperforming the benchmark by 527 bps. YTD, the Fund is down -11.32%, underperforming the benchmark by 1,862 bps.

The MSCI AC Asia Pacific ex Japan Index surged 17.4% in USD terms in Nov 2022. China, Hong Kong and Taiwan were the best performing markets while Indonesia and India were laggards. North Asian markets rallied on the back of easing of zero covid policy from China, announcement of measures to support the property market and the meeting between President Xi and President Biden in Bali eased concerns about US-China tension. The move by China to implement more pragmatic policies paved the way for Chinese economy to recover from the economic impact of the lockdowns and weakness in property market. We expect a more enhanced policy execution on economic growth, following its Two Session Meeting in March 2023 by the Chinese government. We have been increasing our exposure to China selectively, focusing on beneficiaries of policy tailwinds and economic reopening. Headline CPI in the US rose less than expected, at 7.7%YoY in October. This led to some hopes that US Fed will slow its pace of tightening or pause rate hikes earlier. We are of the opinion that bulk of the heavy lifting by Fed is done, and inflation is likely to ease in earnest in 1H2023, as global economy slows in response to the monetary tightening by central banks. We have a positive view on Asian equities as valuation is attractive and we expect Asia to print positive earnings growth in 2023 given the gradual reopening of the Asian economies and international borders and possible easing of inflation. Other risks would be (1) persistently high inflation; (2) policy mistake; and (3) geopolitics such as Russia-Ukraine, and US-China relations. We will continue to focus on quality companies which have good earnings visibility, robust balance sheet, long term winners, market share gainers and those with pricing power to overcome cost pressures as well as companies with structural growth drivers.

<b>Liquidity risk</b>	Liquidity risk refers to the ease of liquidating an asset depending on the asset's volume traded in the market. If the target fund holds assets that are illiquid, or are difficult to dispose of, the value of the target fund will be negatively affected when it has to sell such assets at unfavourable prices.
<b>Currency risk</b>	As the investments of the target fund may be denominated in currencies other than the base currency of the target fund, any fluctuation in the exchange rate between the base currency of the target fund and the currencies in which the investments are denominated may have an impact on the value of these investments. You should be aware that if the currencies in which the investments are denominated depreciate against the base currency of the target fund, this will have an adverse effect on the NAV of the target fund and vice versa. You should note that any gains or losses arising from the fluctuation in the exchange rate may further increase or decrease the returns of the investment.
<b>Credit and default risk</b>	The target fund will be exposed to a certain degree of credit and default risk of issuers or counterparties when the target fund invests in debt securities, money market instruments and/or place deposits. Credit risk relates to the creditworthiness of the securities issuers or counterparties and their expected ability to make timely payment of interest and/or principal. Any adverse situations faced by the issuers or counterparties may impact the value as well as liquidity of the investments. In the case of rated debt securities, this may lead to a credit downgrade. Default risk relates to the risk that a securities issuer or counterparty either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investments. **Interest rate risk**

Interest rate risk refers to the impact of interest rate changes on the valuation of debt securities. When interest rates rise, debt securities prices generally decline and this may lower the market value of the target fund's investment in debt securities. In managing the debt portfolio, Principal (S) takes into account the coupon rate and time to maturity of the debt securities with an aim to mitigate the interest rate risk.

**Risk associated with investing in CIS**

Since the target fund may invest entirely into CIS, there is a risk of concentration into CIS, in which the CIS's management company has absolute discretion over the CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the CIS and/or the management company, the NAV of the target fund, which invests into those CIS would be affected negatively. Should the situation arise, Principal (S) will seek for another CIS that is consistent with the objective of the target fund.

**Risk of investing in emerging markets**

In comparison with investments in the developed markets, investment in emerging markets may involve a higher degree of risk due to the greater possibility of political or economic instability and societal tensions. Emerging markets are markets that are, by definition, "in a state of transition" and are therefore exposed to rapid political change and economic declines.
