FUND MANAGER'S COMMENTS

- US markets saw a strong rebound in January with the S&P 500 up 6.20% after a spate of 'Goldilocks' data showed US economic growth staying resilient and at the same time inflationary pressures easing. The tech-heavy Nasdaq gauge similarly soared 10.70%. This was supported by better-than-expected US 4Q'2022 GDP which fueled optimism that the US would be able to pull off a soft landing.
- It was a more muted start for the local market with the benchmark KLCI barely unchanged at -0.60%. There was mild selling pressure seen across Bursa on the back of profit taking after the typical year end window-dressing activities.
- The government introduced a fixed line internet Unity Package targeted specifically for the B40 income group. The package is on average 22% cheaper than existing packages offered by telco service providers the price reduction impact to earnings is expected to be small for providers like Telekom, as it accounts for less than 1 of its total revenue. Further headwinds in the telco sector is expected with the upcoming wholesale broadband access review.
- Budget 2023 is expected to be re tabled on the February 24th in Parliament. Expectations are that the country's budget would not be significantly different. However, we could see more fiscal measures to widen the country's revenue base as well as the implementation of targeted subsidies where its cost has ballooned over the years.

STRATEGY:

- The fund's invested levels were increased to around 83%, as we added exposure to companies with exposure to commodities, as well as in the healthcare and REITs sector. Meanwhile, we took profit on cyclical names and those we view have limited upside.
- We also raised positions in beneficiaries of China reopening, focusing on domestic demand, while reducing exposure in holdings that are at risk of ex-China slowdown and those with high valuation. Overall, the Fund is still defensively positioned.
- Overall, the Malaysian equity market saw a decent start to 2023, driven mainly by small-mid cap names. The new government is settling in well, with policies announced so far has been market friendly. The next key event to watch would be the Budget 2023 tabling. Domestic fundamentals remain strong with solid GDP & corporate earnings growth. BNM taking a pause on rate hike will alleviate pressure on profit margins.
- We are positive on banks, where we have a strong outlook on loan growth and improving asset quality. We still like technology companies, where we see attractive value after the recent heavy selloff, and which has strong earnings visibility driven by secular growth trends (e.g. 5G, EV, solar energy). We are also positive on the reopening theme, including in the consumer and commodities sector, where business recovery are anchored by a full reopening.

Reclassification of Shariah status risk

This risk refers to the risk that the currently held Shariah-compliant securities by the target fund may be reclassified to be Shariah non-compliant in the periodic review of the equities by the Shariah Advisory Council of the Securities Commission Malaysia (SACSC), the Shariah Adviser for the target fund or the Shariah boards of the relevant Islamic indices.

If this occurs, Affin Hwang will take the necessary steps to dispose of such equities. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess capital gains derived from the disposal of the Shariah non-compliant equities. Affin Hwang will be required to dispose of these equities immediately if the prices are above the purchase price. Should the prices be below the purchase price, Affin Hwang may choose to hold on to these holdings until the prices meet the purchase price. Nevertheless, should Affin Hwang decide to dispose of these equities below the purchase price, the target fund will be faced with the risk of realising its losses, thus negatively impacting the NAV of the target fund.

Shariah-compliant warrants investment risk

The value of the Shariah-compliant warrants (“warrants”) will depend on the pricing of the underlying security whereby the growth and performance prospect of the underlying security would consequentially affect the value of the warrants.
