FUND MANAGER'S COMMENTS

The Fund was down 5.23% in MYR terms in June, underperforming the benchmark by 586 bps. YTD, the Fund is down 8.79%, underperforming the benchmark by 1268 bps.

The MSCI AC Asia Pacific ex Japan Index fell by 6.3% in USD terms, led by Korea and Taiwan. Concerns over global recession and persistent inflation weighed on markets. Key issues for the market are (1) will there be a US recession and how deep will it be; (2) will inflation peak but stay elevated for longer; and (3) when will China recover. The US Federal Reserve remains steadfast in heading off inflation tightening monetary conditions, as evidenced in the 75bps hike mid June. With most of Asia also experiencing higher inflation, with the exception of China, Asian central banks will also have to tighten monetary conditions. India, Philippines are the countries most vulnerable to the negative impact. While inflation is expected to remain high in the next 3-6 months due to rising energy and food prices, we look out for peaking of inflation to be more positive on equities. The Caixin Composite PMI showed improvement in June, rebounding to 55.3 from 42.2 in May, as the movement restrictions eased. Year to date, fixed asset investment in China grew 6.2% yoy, better than expected. The Chinese government is likely to implement more fiscal policies to boost the economic growth after the lockdowns. We added our exposure to China selectively, with a preference over beneficiaries of decarbonization, reopening plays, winners of policy easing/fiscal stimulus etc. The rising commodities and inflationary environment and knock-on effect on demand remain the key risks to Asian corporate earnings. Nevertheless, we expect Asia to print positive earnings growth in 2022 given the reopening of the economies and international borders. We have a slightly positive view on Asian equities. We will also continue to focus on quality companies which have good earnings visibility, robust balance sheet, long term winners, market share gainers and those with pricing power to overcome cost pressures. On a country basis, we prefer North Asia, Australia and Singapore.




