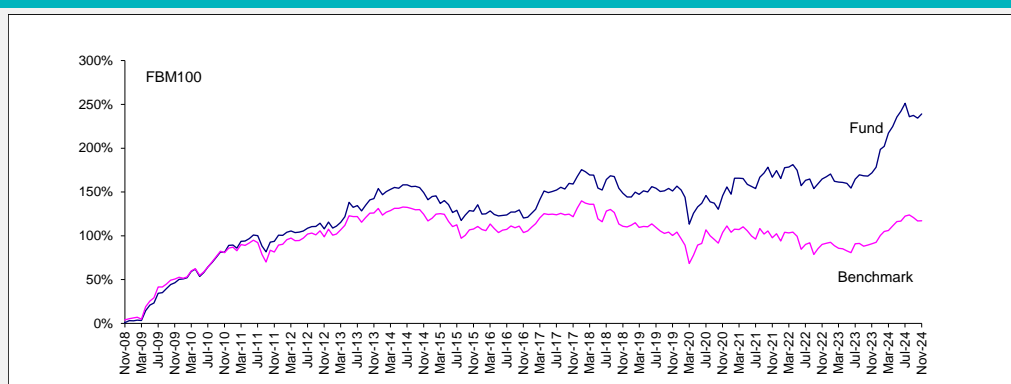

FUND MANAGER'S COMMENTS

Market review

In November 2024, the Fund rose 1.44%, outperformed the Benchmark by 143 basis points (bps). The outperformance was mainly due to the Fund's overweight in Industrials, Health Care, Information Technology and Real Estate as well as the underweight in Consumer Discretionary and Materials.

Portfolio Strategy

The KLCI fell 0.5% in November as investors continue to risk off due to uncertainties surrounding potential new policies under the new US administration, as well as the trajectory of Fed rates given the recent economic data. Utilities, Commodities, Telcos, Transport and Consumer were sold off the most, while Banks, Healthcare, Property, Construction and Plantation posted modest gains. Corporate earnings sustained in 3Q24 with 9M results forming 74% of full year forecast which has baked in 9% growth for 2024.

Malaysia's manufacturing sector moderated in November, with a PMI reading of 49.2 pts vs 49.5 pts in the previous month, as demand conditions remain muted. S&P Global noted a slowdown in new orders, output and stocks, while employment was broadly stagnant. However, firms surveyed saw stronger overseas demand conditions which resulted in further increase in new export orders. The rate of input cost inflation eased further while firms look to lower prices in an attempt to stimulate sales. Optimism of a recovery in new orders over the coming 12 months remains solid, unchanged from October. The latest PMI data suggests 4Q24 GDP growth momentum could sustain at a similar pace as the preceding quarter, which was at 5.9%, albeit at a slower rate of increase. To recap, BNM now projects GDP to grow 4.8-5.3% in 2024, revised up from 4-5% previously, and the economy to expand by 4.5-5.5% in 2025.

We expect BNM to maintain OPR at 3.00% for the rest of the year given muted inflation and modest economic growth. Inflation rose slightly to 1.9% in October but still appears relatively benign. There appears to be sufficient headroom to central bank's latest 2.0-3.5% CPI forecast for 2025 with the impending subsidy rationalization plans.

The KLCI is now trading at a forward PE of under 14x, which is over -1SD below the 10-year historical mean, but still more than 2SD below pre-Covid19 mean of 16x. Consensus projects earnings growth for FBM30 of 8-9% for 2024 and 2025. Sustained strength in domestic investments (both DDI and FDI), fiscal consolidation gathering pace (in particular, subsidy rationalisation initiatives) and the strengthening of the Ringgit are factors we see supportive of the further narrowing of risk premiums (current yield gap at -350bps; pre-Covid average of 250bps) and consequently higher valuation multiples.

We remain constructive on sectors that stand to gain from the NETR, including Utilities, Construction, and Property. We are also optimistic about Financials and Consumer names given the strong investment momentum in Malaysia. We also like sectors that benefit from the stronger Ringgit. Additionally, we remain highly selective on Technology favoring those with strong bargaining power. Key risks are the derailment of Malaysia's macroeconomic recovery and corporate earnings growth due to the larger-than-expected impact of rising inflation, slower global economic growth, and heightened geopolitical risks.
