PERFORMANCE RECORD

The Fund feeds into Affin Hwang Select Asia (ex Japan) Quantum Fund (“target fund”) with the objective of achieving capital appreciation over the medium to long-term by investing in Asia (ex Japan) equities with market capitalization of not more than USD1.5 billion at the time of investment. However, the target fund would also have an option to invest into companies with a market capitalization of not more than USD3.0 billion at the time of investment, which will be capped at no more than 30% of the Net Asset Value (NAV) of the target fund.

FUND MANAGER'S COMMENTS

- Global equities treaded higher in May amidst a slew of economic data releases boosted optimism, though this was tempered by a resurgence of COVID-19 cases especially in emerging markets. The US S&P 500 closed 0.7% higher, whilst the MSCI AC World index was up 1.6% over the month.
- The MSCI Asia ex-Japan index ended May 1.2% higher, with India posting the strongest gains despite currently struggling with a surge in pandemic cases.
- China's official manufacturing PMI for May came in at 51.0, signaling an expansion. Strong economic growth has lent strength to the Chinese Renminbi which rose to the strongest level against the USD since 2018. This was mainly driven by USD weakness in general as well as strong export data from China which beat expectations.
- Hong Kong's unemployment rate fell for a second straight month in April as the city slowly emerges from an extended slump fueled by the pandemic and social unrest. Hong Kong is showing increasing signs of rebounding from its two-year recession, posting its fastest growth since 2010 in Q1 with a revised 7.9% year-on-year jump.
- The local market was weaker with the benchmark KLCI down 0.5% in May as new daily COVID-19 infections soared. A full lockdown was implemented to contain the pandemic.

STRATEGY:

- We remain constructive on equities on the expectations that global growth would continue on its recovery path in 2021, with continued accommodative policies, positive earnings revision and encouraging vaccine developments.
- Asian markets are expected to remain rangebound due to a lack of catalysts. The Chinese markets may continue to struggle due to tightening fears and regulatory overhang on the internet sector.
- The fund's invested level is now at 88%, maintaining the strategy of straddling both growth and value/reopening themes which are supported by economic recovery.
- The fund reduced exposure from technology sector due to recent market correction and added into Indian non-banking financial company, dental clinic chain, and grocery retailer stocks that should benefit from re-opening and improved consumption.
- The fund increased its weight into economy-reopening/ value play to 34% on the back of Covid-19 vaccine rolled out. Structural growth makes up 47% of the fund while cyclicals make up 7%.

Warrants investment risk	The value of the warrants will depend on the pricing of the underlying security, whereby the growth and performance prospect of the underlying security would consequentially affect the value of the warrants. In addition, the value of the warrants may decrease exponentially as the warrants approach its maturity date and the potential gains from a favourable price movement of the underlying security may be offset by aggressive time decay. Country risk	Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or prices of units to fall.

Currency risk

Currency risk at the target fund level

Regulatory risk

The fund manager may dispose its investments in that particular country should the regulatory changes adversely impact the policy owners' interest or diminish returns of the target fund.
