FUND MANAGER'S COMMENTS

For the month, the fund rose +0.71% in MYR terms, underperforming the benchmark by -312bps. The underperformance of the month was driven by Information Technology, Materials and Consumer Discretionary.

FBMKLCI gained 6% in July, fully reversing the loss sustained in 2Q23. Sentiment was sharply lifted by the slump in the US Dollar, benefiting the Ringgit. Malaysia's PMI reading for July was 47.8pts, a slight improvement versus June. Malaysia's economy expanded 5.6% YoY in 1Q23. Market sentiment has improved on the back of recent weakening USD and reversal of foreign outflows. Furthermore, from headwind to tailwind, political uncertainty shall subside after the conclusion of the 6 states election on 12 August, hence, we have turned incrementally positive on the market. We remain constructive on sectors that stand to gain from the NETR, including Utilities, Construction, and Property. Additionally, we remain optimistic on selective Technology due to the ongoing structural growth trends in the sector. Key risks are the derailment of Malaysia's macroeconomic recovery and corporate earnings growth due to the larger-than-expected impact of rising inflation, slower global economic growth, and heightened geopolitical risks.

The MSCI AC Asia Pacific ex Japan Index rose 5.4% in USD terms in July, led by China and Malaysia. The US 10-year bond yield ended the month higher at 3.96%, up 12bps and the Dollar Index depreciated by 1%. China's Politburo meeting in July raised hopes for growth stabilisation in China. The July Politburo Economic meeting in China marks a pro-growth shift in policy tone related especially to property and promises to revive domestic demand after acknowledging the challenges faced by the economy. For instance, the policy response in property signaled more urgency with the removal of "Housing is for living, not for speculation", first time since appearing 4 years ago.

We have a positive view on Asian equities given attractive investment themes and corporates have the potential to post better earnings growth than developed markets. We will continue diversify the portfolio and to focus on quality companies which have good earnings visibility, robust balance sheet, long term winners, market share gainers and those with pricing power to overcome cost pressures.

We aim to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.
Interest rate risk	Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments.
Country risk	Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall.

Currency risk

Risk of investing in emerging markets

We attempt to mitigate these risks through active asset allocation management and diversification across different countries and sectors, in addition to our continuous bottom-up and top-down research and analysis.

Risks associated with investment in warrants

The value of warrants is influenced by the current market price of the underlying security, the exercise price of the contract, the time to expiration of the contract and the estimate of the future volatility of the underlying security's price over the life of the contract. Like securities, we will undertake fundamental research and analysis on these instruments with an aim to mitigate its risks.
