PERFORMANCE RECORD

FUND MANAGER'S COMMENTS

The Fund rose 3.75% during the month, outperforming the benchmark by 32bps. MSCI AC Asia ex Japan Islamic Index rose 5.5% in US\$ terms in March, led by Taiwan, South Korea and Singapore. The US 10-year bond yield declined a marginal 4bps to 4.2% while the Dollar Index was rose 0.3% during the month. Year-to-date the MSCI AC Asia ex Japan Islamic Index rose 7.0% in US\$ terms.

China's policies have turned more stimulative with some green shoots (PMI and Spring festival tourism) emerging, we are mindful that its policies are a work-in-progress and efficacies remain to be seen. Many see the 5% GDP growth target for 2024 announced in the National People's Congress as a goal that is lacking details. In Asia, there are growth drivers that will drive the earnings for 2024. For example, recovery in the semiconductor industry, India's strong economic growth and capex cycle, lower interest rates, all of which is likely to lead to better earnings growth in Asia in the next 12 months. There are also upcoming elections in South Korea and India. We expect stability in India politics, while the polls in South Korea are casting doubts on the execution of the "Corporate Value-Up Program".

RISKS

Market risk refers to the possibility that an investment will lose value because of a general **Market risk** decline in financial markets, due to economic, political and/or other factors, which will result in a decline in the target fund's NAV. This risk refers to the risk that the currently held Shariah-compliant securities in the target fund may be reclassified as Shariah non-compliant in the periodic review of the securities by the Shariah Advisory Council of the Securities Commission Malaysia (SACSC), Shariah adviser of the issuer, the Shariah Adviser or the Shariah boards of the relevant Islamic Reclassification of indices. If this occurs, Principal will take the necessary steps to dispose of such securities. **Shariah status risk** There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event that the Shariah non-compliant securities are disposed of at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund or price of units to fall. Since the target fund will invest entirely into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over Risk associated with the Islamic CIS's investment technique and knowledge, operational controls and investing in Islamic CIS management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund. The target fund may invest into Islamic CIS which can be domiciled in various countries. Therefore, the target fund will be subjected to risks specific to the countries in which the **Country risk** Islamic CIS are domiciled. Such risks include adverse changes in economic fundamentals,

social and political stability, laws and regulations and foreign investments policies. These factors may have an adverse impact on the price of the Islamic CIS, which will depress the Islamic CIS's NAV growth, and consequently depress the target fund's NAV growth.

Currency risk

As the target fund may invest into Islamic CIS denominated in currencies other than MYR, any fluctuation in the exchange rate between MYR and the currencies in which the Islamic CIS are denominated may have an impact on the value of these investments.
