## FUND MANAGER'S COMMENTS

While commentary from US and EU central banks suggested that inflation may finally be under control and we could be at the final stage of rate hikes, Bank of Japan announced to allow yield curve control to be more flexible which signalled the early stage rate hike. The second quarter earnings kicked off at the end of July starting with the banks and tech companies. From the companies that have announced, we observed decent earnings beats and not sense much of a hard recession risk ahead of us. We would continue to focus on the fundamental strengths and multiples from bottom up.

MYR Class A returned -1.49% underperforming the benchmark by -0.92%. This underperformance was driven by selection splitting between North America and Europe. By sector, overweight on Healthcare continues to be a headwind. Selection was weak in Utilities and Industrials which was partially offset by Information Technology.

The top contributors to performance were Adobe and Alphabet. Adobe continuing to benefit from increasing optimism around its AI positioning. Alphabet released a strong earnings beats with advertisement market potentially inflecting, and cloud growth being resilient. The CEO mentioned that more than 70% of generative AI unicorns are Google Cloud customers. The top detractors were Boston Scientific and Orsted. Boston Scientific has underperformed despite reporting very strong earnings and a large upgrade to its outlook in part as the medtech space underperformed in July and investors took profits in Boston following very strong performance YTD. Orsted has underperformed as there were concerns about project and costs risk.

**Currency Risk**

As the Base Currency is denominated in USD and the currency denomination of the Classes may be denominated in other than USD, the Classes not denominated in USD are also exposed to currency risk. Any fluctuation in the exchange rates between USD and the currency denomination of the Class (other than Classes denominated in USD) will affect the Unit Holder's investments in those Classes (other than Classes denominated in USD).
