#### PERFORMANCE RECORD

The Fund feeds into Affin Hwang Select Asia (ex Japan) Quantum Fund (“target fund”) with the objective of achieving capital appreciation over the medium to long-term by investing in Asia (ex Japan) equities with market capitalization of not more than USD1.5 billion at the time of investment. However, the target fund would also have an option to invest into companies with a market capitalization of not more than USD3.0 billion at the time of investment, which will be capped at no more than 30% of the Net Asset Value (NAV) of the target fund.

#### FUND MANAGER'S COMMENTS

- Global equities started on a strong note in 2021 buoyed by continued policy easing, an anticipated fiscal stimulus boost following President Biden's inauguration and global vaccine rollouts, before succumbing to market jitters.
- The MSCI Asia ex-Japan index was up 4.48% in January as the region gains better control over the pandemic and saw a gradual recovery in economic activities.
- North Asian markets, including China, Korea and Taiwan are leading the recovery amid a strong rebound in cyclical sectors such as technology and industrials. News concerning the shortage of semiconductor chips signals strong demand as various industries such as automakers are beginning to bounce back from the pandemic.
- China's GDP climbed 6.5% in Q4 from a year earlier, pushing growth to 2.3% for the full year. Its economy roared back to pre-pandemic growth rates in Q4 as its industrial engines fired up to meet surging demand for exports.
- The local market stayed weak with the KLCI closing 3.74% lower as rising COVID-19 cases dampened sentiment. Attempts by local retail investors to drive up the share price of rubber glove stocks also sputtered.

**STRATEGY:** We remain constructive on equities on the expectations that global growth would continue on its recovery path in 2021, with continued accommodative policies, positive earnings revision and encouraging vaccine developments.

- However, we remain cognizant of the risk of policy tapering as the economy recovers, overly bullish market sentiments and potentially more Covid-19 resurgence that tempers expectations of a return to normalcy.
- We continue to be positioned in secular growth stocks but are marginally shifting to value names. We look to have a balanced exposure to companies that can grow structurally post vaccine and to reopening plays and cyclicals.
- Reopening/cyclical positions now make up about 20% of the fund. The fund maintains its bias on the technology and medtech sectors as we view these as structural sectors in China.

<b>Warrants investment risk</b>	The value of the warrants will depend on the pricing of the underlying security, whereby the growth and performance prospect of the underlying security would consequentially affect the value of the warrants. <b>Country risk</b>	Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or prices of units to fall.

### Currency risk

#### Currency risk at the target fund level

### Regulatory risk
