## PERFORMANCE RECORD

The Fund feeds into Affin Hwang Select Asia (ex Japan) Quantum Fund (“target fund”) with the objective of achieving capital appreciation over the medium to long-term by investing in Asia (ex Japan) equities with market capitalization of not more than USD1.5 billion at the time of investment. However, the target fund would also have an option to invest into companies with a market capitalization of not more than USD3.0 billion at the time of investment, which will be capped at no more than 30% of the Net Asset Value (NAV) of the target fund.

#### FUND MANAGER'S COMMENTS

- Global equities wobbled in November as markets contend with a possibly muddled outlook of decelerating growth as well as tightening bets by the US Federal Reserve. The MSCI AC World Index was down 2.4% while the S&P 500 closed 0.7% lower during the month.
- The MSCI Asia ex-Japan index fell 3.9% as the Omicron variant spreads across the region. Governments rushed to shut down borders and re-impose travel restrictions to contain the spread of the new variant which initial studies show is more virulent.
- Chinese tech names continue to face regulatory headwinds with ride-hailing firm, Didi, under further pressure as regulators urged a plan for delisting from the NYSE. There were also unofficial talks of a "data tax" to be imposed on internet giants.
- Performance of Chinese stocks remains muted as a resurgence of new COVID-19 cases made investors jittery. China is largely expected to maintain their "zero-COVID" approach, especially as the country is slated to host the Winter Olympics in February.
- China's economy performed better than expected in October as retail sales climbed and energy shortages eased. Industrial output rose 3.5% in October from a year earlier, while retail sales growth accelerated to 4.9%.

#### STRATEGY:

- Equities are facing a challenging environment with global growth is coming off a high base, slowing earnings growth, fiscal and monetary policies that will turn less supportive, and developments around the Omicron variant. However, growth is normalizing but not collapsing, and while rates are expected to rise, we remain in an environment of low absolute rates.
- Given a tougher macro environment, we will be selective in stock picking. We continue to favour secular growth stocks and will retain exposure in selective cyclicals and re-opening plays.
- The fund's invested level is now at 92%, as we added to Companies in India and continue to streamline the portfolio.
- New names added include a Taiwan listed IP design provider (structural growth), an Indian mid-market hotel operator, and subscribed to the IPO of India's KFC franchise operator (reopening beneficiaries). We exited an Australian zero-carbon lithium developer (execution uncertainty), an Australian marginal oil producer (taking profit), and a Thai data center contractor.
- Structural growth names and economic reopening themes make up bulk of the fund, while cyclicals exposure has been reduced to around 10% of the fund.

### Currency risk
