FUND MANAGER'S COMMENTS

Fund (Class MYR) declined by 1.06% during the month of January 2021, underperforming the benchmark by 41bps.

Developed equity market had a volatile month with delays in Europe vaccine rollout amid the rise of new covid variant in UK and South Africa as well as delay in another US fiscal stimulus package. However, The number of new cases and hospitalizations in US, Europe and Japan dropped from their winter highs with lockdowns and the rollout of vaccines. Part of the month-end sell-off is caused by hedge funds covering short position losses caused by a group of coordinated retail investors. S&P 500 Index, MSCI Europe and Japan Indexes returned 0.46%, -2.39% and -0.6% respectively in MYR terms. The Dollar Index appreciated slightly against EUR and JPY.

Fundamentals are positive for developed markets. PMIs are resilient against the backdrop of Covid-19 situation. US PMI continues to expand. The housing market is strong with housing starts rising at the fastest pace since 2006. Europe PMI stays in expansion zone and factory activity continue to expand. Japan PMI is stabilized with optimistic business confidence and anticipation of a demand recovery from world economic recovery. The 12m forward earnings are consistently revised higher across all developed markets. In January, the Federal Reserve and European Central Bank have reaffirmed their accommodative monetary policy support until inflation rises meaningfully towards targets. We expect developed markets central banks to maintain their extremely easy policy stance.

Valuations are not stretched overall after the recent few rounds of market corrections.

We are overweight all developed markets as growth broadens out in 2021. We maintain our view that the global economy should continue its recovery over the next 12 months. Developed markets PMIs are resilient against the backdrop of rising covid cases. Corporate earnings are consistently revised higher across all developed markets. We think the resurgence of virus cases would be contained by better awareness, testing and contact tracing and the continued roll out of vaccines to the public. In addition, markets will continue to be supported by low interest rates and ample liquidity.

Although the probability of such occurrence is minute, should the situation arise, Principal (S) will seek for an alternative collective investment scheme that is consistent with the objective of the target fund.
