## PERFORMANCE RECORD

This fund feeds into Principal Islamic Balanced Wholesale Fund-of-Funds (“target fund”) with the objective to achieve moderate capital growth by investing in a portfolio of Shariah-compliant collective investment schemes that invest in Shariah-compliant equities and/or Sukuk.

## FUND MANAGER’S COMMENTS

In October, the Fund rose 0.65 underperforming the benchmark by 0.11ppt as the Islamic index fell marginally by 0.3% in USD terms during the month with top performers including Indonesia, Singapore and Philippines while Korea was the worst performer with negative returns.

As vaccination rates continue to improve in Asia with most countries expected to approach herd immunity in the coming months, we expect economic activities to normalize decisively in 2022. The exception is China where domestic factors such as its property market slowdown and regulatory activity on various sectors play a larger role in economic growth. We are navigating China cautiously, avoiding sectors that can fall prey to its Common Prosperity program and focused on areas with structural tailwinds such as in high tech manufacturing and renewables. During the month, China focused its attention towards investigating financial regulators and banks for corruption activity. We are also monitoring whether regulations on the Internet sector have passed its peak.

With global supply chain disruptions and energy shortage, most companies intend to further pass-on costs to consumers in the coming months. While inflation appears to be an issue in the near term, some of these contributing factors should be transitory as supply chain bottlenecks improve with reopening of most economies and production facilities in 2022, allowing supply to catch up with demand.

We continue to diversify our holdings across countries and businesses to improve our portfolios’ resilience. During the month, we topped up on renewable (solar) exposure, ASEAN telco and initiated position in a niche tech hardware company in electronic displays. We funded these purchases by right-sizing certain exposures where valuations are getting lofty. Off-benchmark stocks contribute ~50% to our holdings.

<b>Manager's risk</b>	This risk refers to the day-to-day management of the target fund by Principal which will impact the performance of the target fund. For example, investment decisions undertaken by Principal, as a result of an incorrect view of the market or any non-compliance with internal policies, investment mandate, the deed, relevant law or guidelines due to factors such as human error or weaknesses in operational process and systems, may adversely affect the performance of the target fund.
<b>Reclassification of Shariah status risk</b>	This risk refers to the risk that the currently held Shariah-compliant securities in the target fund may be reclassified as Shariah non-compliant in the periodic review of the securities by the Shariah Advisory Council of the Securities Commission Malaysia (SACSC), Shariah adviser of the issuer, the Shariah Adviser or the Shariah boards of the relevant Islamic indices. If this occurs, Principal will take the necessary steps to dispose of such securities. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event that the Shariah non-compliant securities are disposed of at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund or price of units to fall.
<b>Risk associated with investing in Islamic CIS</b>	Since the target fund will invest entirely into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.
<b>Country risk</b>	The target fund may invest into Islamic CIS which can be domiciled in various countries. Therefore, the target fund will be subjected to risks specific to the countries in which the Islamic CIS are domiciled. Such risks include adverse changes in economic fundamentals, social and political stability, laws and regulations and foreign investments policies. These factors may have an adverse impact on the price of the Islamic CIS, which will depress the Islamic CIS's NAV growth, and consequently depress the target fund's NAV growth.

**Currency risk**

As the target fund may invest into Islamic CIS denominated in currencies other than MYR, any fluctuation in the exchange rate between MYR and the currencies in which the Islamic CIS are denominated may have an impact on the value of these investments. You should be aware that if the currencies in which the Islamic CIS are denominated depreciate against MYR, this will have an adverse effect on the NAV of the target fund in MYR and vice versa. You should note that any gains or losses arising from the fluctuation in the exchange rate may further increase or decrease the returns of the target fund.
